### ARTICLE 4

#### DUES, FEES, ADMIS- SIONS,SUSPENSIONS

Section1 The dues of this Lodge shall be fifty-five dollars (\$55.00) per annum, payable in advance on the 1st of January of each year, and in addition such sums as may be further required for special purposes by thee by-laws, Any member whose dues and/or assessments are not paid to the end of the current semi-annual term shall be suspended.

### ARTICLE 4

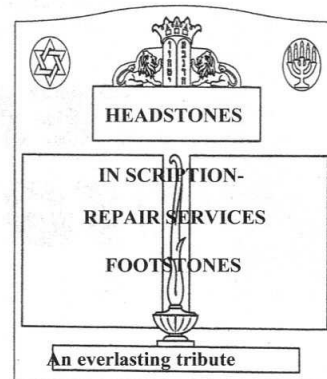
